

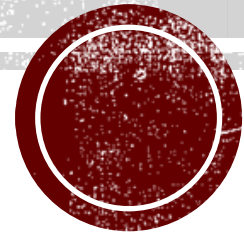

BIDEN'S NEW COVID TRAVEL PROCLAMATION

- Issued October 25, 2021
- Revokes ALL prior Covid-related travel bans!
 - China, Brazil, India, Iran, South Africa, Ireland, the United Kingdom, and the Schengen Area
- Creates new travel rules effective November 8, 2021

LAND AND FERRY BORDERS

- Fully vaccinated:
 - Non-essential travel permitted as of November 8, 2021.
- Unvaccinated:
 - Essential travel allowed until January 21, 2022, when vaccine requirement imposed for all travelers.

AIR: NEW REQUIREMENTS

- Proof of vaccination
- Negative Covid tests

AIR:
**NO VACCINATION
NEEDED**

- U.S. citizens and nationals
- Green card holders
- Children under 18
- Citizens of countries where <10% of the population is vaccinated, and who seek entry pursuant to a nonimmigrant visa (not including B-1/B-2 travelers)
- Crew members
- U.S. military and their family
- Humanitarian need, diplomats, UN invitees
- Those for whom approved COVID-19 vaccination is medically contraindicated as determined by a licensed physician
- Other exceptions

AIR: MOST NONIMMIGRANTS

- Must be fully vaccinated (i.e., >2 weeks after receiving full dosage)
- Acceptable vaccines:
 - Janssen/Johnson & Johnson, Pfizer-BioNTech, Moderna, AstraZeneca, Covishield, BIBP/Sinopharm, and Sinovac
 - List is growing – approved by WHO or FDA

PROOF OF VACCINATION

- Verifiable digital or paper records: vaccination certificates or digital passes accessible via QR code (such as the UK NHS COVID Pass and the European Union Digital COVID Certificate)
- Non-verifiable paper records: issued by a national or subnational level agency or by an authorized vaccine provider (such as the Centers for Disease Control and Prevention (CDC) vaccination card)
- Non-verifiable digital records: Digital photos of vaccination card or record, or a downloaded record or vaccination certificate from an official source (e.g., public health agency, government agency, or other authorized vaccine provider), or a record shown on a mobile phone app without a QR code

CONFIRM WITH AIRLINE IF TRANSLATION NEEDED

AIR: NEGATIVE COVID TEST

- All Travelers over age 2: MUST HAVE A NEGATIVE COVID-19 TEST PRIOR TO BOARDING A FLIGHT TO U.S.
 - Fully Vaccinated: test < 3 days before flight
 - Includes unvaccinated child < 18 traveling w/ vaccinated adult
 - Not fully vaccinated: test < 1 day before flight
 - Had Covid <90 days ago:
 - proof of recovery +
 - letter from doctor or public health official
- Both nucleic acid amplification tests (NAATs), such as a PCR test, and antigen tests qualify

AIR: UNVACCINATED TRAVELERS

- Must wear mask during travel
- Must ATTEST that:
 - You will be tested 3-5 days after arrival in the U.S.
 - You will self-quarantine for a full seven days; AND
 - You will self-isolate if the post-arrival test is positive or if you develop COVID-19 symptoms
- If plan to be in U.S. > 60 days, must ATTEST:
 - Agree to be vaccinated; AND
 - Have arranged for vaccination within 60 days of arriving in the U.S. (unless eligible for an exemption)

AIR: UNVACCINATED TRAVELERS

- Exemptions:
 - Brief stay
 - Age-inappropriate;
 - Participated or is participating in certain clinical trials;
 - Has previously received a COVID-19 vaccine that is authorized or approved by the noncitizen's country of nationality, as determined by the Director of the CDC, in consultation with the Secretary of State; or
 - Director of the CDC otherwise determines that COVID-19 vaccination is not warranted.
